TERMS & CONDITIONS FOR CREDIT

I/we agree that such extension of credit shall be subject to the following terms and conditions:

1. Payment

It is understood and agreed that all accounts are due thirty (30) days following the date of an invoice. A service charge will apply on the amount of any overdue accounts from the date such an account becomes overdue. The current rate is 2% per month (26.8% per annum), subject to change on written notification from Western Producer Publications Partnership or its affiliated companies (WP). A \$20 service charge will apply to all payments returned as NSF.

2. Disputing Statement of Account

Every transaction indicated or referred to in any notice, statement, confirmation and every statement of account shall be deemed and treated as authorized and correct and as ratified and confirmed by the Applicant unless WP receives from the Applicant written notice to the contrary within fifteen (15) days from the date of such notice, statement, confirmation or statement of account, such written notice to be forwarded by the Applicant to WP by prepaid mail.

3. Non-Payment

The Applicant authorizes WP to prepare and submit credit charge slips using any credit cards listed herein to recover all charges and all other unpaid amounts due to the Applicant's failure to pay its account balance within thirty (30) days following the date of an invoice.

4. Liabilities

The Applicant agrees that WP shall not be liable for damages arising out of errors in, or omissions of, any records beyond the amount charged for the records, whether such error or omission is due to negligence by WP or otherwise.

5. Credit Report

I certify that the information contained herein is correct and I, being one of the officers named above, hereby give my consent to WP to obtain such credit reports or other information with regards to any individuals or entities named in this Agreement, as WP may deem necessary in connection with the establishment and maintenance of a credit account or for any other direct business requirement.

6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the Province of British Columbia and the laws of Canada applicable therein. All claims and disputes arising out of or in any way connected with this Agreement shall be brought in the courts of British Columbia and the courts of appeal therefrom.

7. Enurement

This Agreement shall ensure to the benefit of and be binding upon the parties and their respective heirs, executors, administrators, successors and permitted assigns.

8. Assignment

WP shall be entitled to assign the benefit of any of its rights and interests under this

Agreement, in whole or in part, without the prior written consent of the Applicant. The Applicant shall not be entitled to assign the benefit of any of its rights and interests under this Agreement, in whole or in part, without the prior written consent of WP, which consent will not be unreasonably withheld.

9. Entire Agreement

Except as otherwise agreed in writing by the parties hereto from time to time on or after the date hereof, this Agreement constitutes the entire agreement between the parties hereto with respect to the subject matters hereof, and supersedes all previous expectations, understandings, communications, representations and agreements with respect to the subject matters hereof, whether oral or written.

10. Cancellation

Credit account privileges may be cancelled at any time at the discretion of WP.

11. Legal Fees

In the event that WP should commence any action or actions, or otherwise seek to enforce this Application, the Applicant will be responsible for all collection costs, including but not limited to, legal fees, court costs and other expenses incurred by WP whether or not suit is filed.

12. Indebtedness

Not with standing any other provision, the Applicant shall be responsible for all indebtedness incurred in the name of the applicant by any employee or agent of the Applicant.

13. Material Change in Ownership

The Applicant hereby agrees to notify WP of any change in majority ownership prior to the effective date of the change.

14. Waiver

The waiver by WP of any breach or default under any term or condition of this agreement or the delay in enforcing it's rights upon any such breach or default shall not of itself abrogate such, or any other, term or condition nor be a waiver of any subsequent breach under the same or any other term or condition.

15. Personal Information

The undersigned acknowledges and agrees that personal information contained in this application or provided subsequently, and personal information obtained from a credit/ consumer reporting agency and/or financial institution may be used by, collected by and/or disclosed to WP for the purpose of (i) evaluating this credit application and the Applicant's and the undersigned eligibility for credit, (ii) contract management and administration, including for credit, billing, collection and lien registration and (iii) as reasonably necessary to protect the business interests of WP. It is the express wish of the parties that this form and any related documents be drawn up in English.
